Terms & Conditions

- By entering the Competition, the Entrant agrees to be bound by these terms and conditions and agrees that the decision of the ISIC Global Office B.V. is binding and final.
- No purchase is necessary to enter the Competition.
- The Competition is open for participation until 12:00 CET 22 October 2013.
- To participate in the Competition, the Entrant must own the rights of the content of the entry.
- To participate in the Competition you agree that you are aged between 15 and 26 years old.
- By entering the Competition, the Entrant does so at his/her own risk and on his/her own initiative, and is responsible for complying with local laws, to the extent any local laws apply, as well as with UNESCO's mission.
- By entering the Competition the Entrant agrees to allow the ISIC Global Office B.V., ISIC issuers and UNESCO to use the content of the entry for promotional purposes internationally.
- Each Entrant releases and holds ISIC and Association members harmless from any and all losses, damages, rights, claims and actions of any kind in connection with the Competition or resulting from acceptance, possession, or use of any Prize, including without limitation, personal injury, property damage and claims based on publicity rights, defamation or invasion of privacy.
- The three (3) top Winners, selected by the most number of combined votes via the ISIC Global Office B.V. Facebook page (<https://www.facebook.com/ISIC.GlobalOffice>), and relayed through the UNESCO Facebook page (<https://www.facebook.com/unesco>) and email votes, are eligible to receive a prize.
- The prize is not non-transferable, and will only be given to the Winners.
- The Winners will be notified via the email address or Facebook profile used to submit the entry.
- The Winner shall be given seven (7) calendar days from the date of notification to claim the Prize. In the event that the Winner fails to respond in writing within that time period, chooses not to accept the Prize, is ineligible for the Competition or fails to duly complete, execute and return any documents required by the ISIC Global Office B.V., he or she shall be immediately disqualified from the Competition and shall forthwith relinquish any right or entitlement to the Prize. ISIC shall then choose an Alternate Winner from all remaining eligible entries.
- The ISIC Global Office B.V. shall not be liable for any breach of its obligations hereunder resulting from causes beyond its reasonable control including but not limited to fires, strikes, insurrection or riots, embargoes, delays in transportation, requirements or regulations of any civil or military authority, computer viruses, bugs, tampering, unauthorised intervention, fraud or technical failure and ISIC shall be entitled to cancel, terminate, modify or suspend the Competition and the terms and conditions without liability.
